Cal/OSHA Urges Employers to Prepare to Protect Workers from Unhealthy Air due to Wildfire Smoke

Oakland—Cal/OSHA is urging employers in California to be prepared to protect workers from unhealthy air due to wildfire smoke. When workers might be exposed to unhealthy air from wildfires, California's protection from wildfire smoke standard requires employers to take steps such as changing the location of work operations, modifying work schedules or providing proper respiratory protection like N95 respirators.

Safety is about people. That is so fundamental to what we do that it almost goes without saying. However, most safety professionals have very little understanding of what makes people tick. Safety curriculum often has little information on this subject, focusing often more on technical information. What little information that is provided is often incomplete or based on pop psychology rather than sound science. As a result, a lot of what safety professionals are recommended to do to deal with problems involving people is often unhelpful and sometimes harmful.
