#### Open positions:

<u>Membership Chair</u>: The chapter Membership Chair is responsible for monitoring the chapter's membership by coordinating the chapter's member recruitment, orientation and retention efforts. This volunteer leader works with the chapter's executive committee to identify and pursue opportunities to enhance the experience for existing and future chapter members. Key responsibilities include reviewing the on-line roster once per month to identify new and missing members and send a welcome email to new members of the chapter.

<u>Communications Chair:</u> The Communications Chair is responsible for keeping the Chapter website up to date with current information reflecting current and past operations of the Chapter, producing the Chapter Newsletter quarterly, and publishing any announcements to the membership via the Society provided emailing service (Real Magnet), and social media (LinkedIn, Facebook). There is a current member serving in this capacity who will be transitioning to a new role at the end of the Chapter year in June 2022. This is a great opportunity to learn the position from the current Communications Chair.

<u>Awards & Honors Chair</u>: The chapter Awards and Honors Chair supports member engagement by ensuring that chapter members are recognized for their contributions to the chapter, ASSP and the safety profession. A key responsibility is to oversee chapter awards and honors program, including designation of awards and recognition, all relevant application and selection processes, and ensure presentation of awards to honorees

<u>Scholarship Chair</u>: The chapter Scholarship Chair coordinates the chapter scholarship program, including serving as liaison with ASSP Foundation, soliciting donations, supporting promotional efforts to recruit applicants and recognizing scholarship recipients.

<u>Nominations and Elections Committee</u>: We are looking for 1-3 individuals who would like to volunteer for a short-term position on the Nominations and Elections Committee. The committee is responsible for vetting and producing the slate

of candidates for the 2022-23 chapter year executive committee. The Nomination and Elections Committee will be set and announced in December and will have the first meeting in January. # **Regulatory Updates**

#### Federal OSHA ETS Update

The 5th Circuit Court of Appeals has "stayed" the mandates and has ordered OSHA to "take no steps to implement or enforce" and OSHA has responded that they have "suspended activities related to the implementation and enforcement of the ETS pending future developments in the litigation." Cal/OSHA Standards Board also has announced it will "cease working on a 'Horcher' adoption of the federal ETS while the legal battle plays out."

The very strongly worded decision by the court stated, "The Mandate's stated impetus—a purported 'emergency' that the entire globe has now endured for nearly two years, and which OSHA itself spent nearly two months responding to - is unavailing as well. And its promulgation grossly exceeds OSHA's statutory authority."

As the court stated "The public interest is also served by maintaining our constitutional structure and maintaining the liberty of individuals to make intensely personal decisions according to their own convictions—even, or perhaps particularly, when those decisions frustrate government officials."
